### I - Introduction

On the 19<sup>th</sup> day of August of two thousand and twenty-four, at 15 hours the jury nominated by the CCMAR board of Directors on 23/07/2024, met by video conference, for the second meeting of the call Ref. CCMAR/BPD/06/2024. The meeting was for the hiring of a Pos-Doctoral Fellowship for a person with a Doctoral Degree (Bolsa de Pós - Doutoramento), for applicants of any nationality, including stateless candidates, and holders of political refugee statute, in the scientific field of **Global Changes** within the research project reference - **PTDC/CTA-CLI/4297/2021** - named as **Hydroshifts**: “Compreender as variações abruptas do hidroclima nas médias latitudes do Atlântico Norte”, funded by Fundação para a Ciência e Tecnologia I.P./MCTES, through national funding. The jury present at the meeting was composed by Doctor Filipa Naughton, Project coordinator, Auxiliary Researcher of IPMA and CCMAR member (President of jury), Doctor Vitor Magalhães, Researcher of IPMA and CCMAR (Member) and Doctor Dulce Oliveira, Researcher at CCMAR and IPMA (Member) and had the following agenda items: admission and evaluation of the applications admitted for the fellowship CCMAR/BPD/06/2024.

### II - Statement of no conflict of interests

#### V - Evaluation of applications

The Jury evaluated the application documents of the eligible candidates (**Table 1**) and applied the classification criteria and weighting factors set out in the vacancy announcement as shown in **Table 2** below:

Evaluation criteria and respective weighting:

1. *Experience in marine palynology in the North Atlantic region (50%)*
2. *Knowledge on past glacial periods and deglaciations (30%)*
3. *Motivation Letter (20%)*

Note: The final grades in table 2 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from **0** to **20**, rounded to the nearest tenth.


## VI - Conclusion
