I - Introduction

On the 9th day of September of two thousand and twenty-four, at fourteen hours the jury nominated by the CCMAR board of Directors on 15/07/2024, met by video conference, for the second meeting of the call Ref. CCMAR/BM/04/2024. The meeting was for the hiring of a Master's Fellowship (Bolsa de Mestrado), for applicants of any nationality, including stateless candidates, and holders of political refugee statute, in the scientific field of **Biochemistry, Nutritional Sciences and Food Technology** within the research project reference - **PTDC/BAA-AGR/1391/2020 - GreenValue** – *“Exploring salt tolerant plants as sources of innovative food additives”* funded by the Fundação para a Ciência e a Tecnologia, I.P./MCTES through national funding (PIDDAC). The jury present at the meeting was composed by Doctor Luísa Custódio, Coordinator of project, researcher and team leader at CCMAR (President of the jury), Doctor André Lopes, Researcher at ISE, Instituto Superior de Engenharia da Universidade do Algarve (Member) and due to an impediment of the full member of the jury, it became necessary to appoint a substitute member, Doctor Maria João Rodrigues, researcher at CCMAR (Substitute Member) had the following agenda items: admission and evaluation of the applications admitted for the fellowship CCMAR/BM/04/2024.

IV - Exclusion of applications

V - Evaluation of applications

The Jury evaluated the application documents of the eligible candidates (**Table 2**) and applied the classification criteria and weighting factors set out in the vacancy announcement as shown in **Table 3** below:

Evaluation criteria and respective weighting:

1. **Absolute merit of the CV (40%)**
2. **Laboratory experience in the area of the work plan to be developed (30%)**
3. **Knowledge of different laboratory techniques (30%)**

Note: The final grades in table 3 represent the average of the individual evaluation performed by each member of the jury, presented on a scale from 0 to 20, rounded to the nearest tenth.

With no other item on the agenda, the meeting of which these minutes were drawn up was closed, with 2 pages, which after being read and approved were signed by the members of the jury.


