I – Introduction

On the 3rd day of March, 2025 at 10 hours the jury nominated by the CCMAR board of Directors on 24-01-2025, met by videoconference, for the meeting 2 of the call Ref. CCMAR/TSI/06/2025. The meeting was held for the award of a position for a Research Technician (Técnico/a Superior de Investigação) (M/F), in the scientific field of Biological Sciences to satisfy temporary needs under an uncertain term employment contract to support the work carried in the context of the project entitled “*Salty symphonies: bringing back Biodiversity in marginal Saltlands*”, with the acronym “SaltyBeats”, Ref. BiodivNBS/0015/2023 funded by the Foundation for Science and Technology, I.P. (FCT), co-financed by the Biodiversa + Program under Horizon Europe. The nominated jury present at the meeting was composed by Doctor Luisa Custódio, project coordinator at CCMAR, team leader and principal researcher at CCMAR (president of the jury) Professor André Lopes, Professor at Algarve University (full member); Maria João Rodrigues, junior researcher at CCMAR (full member); with the following agenda: the definition of the requirements, of the selection criteria and elaboration of the announcement of the call CCMAR/TSI/06/2025.

IV – Admission of applications

2. Experience in the evaluation of biochemical properties of salt-tolerant plants.

And/or failure in submitting all documents/information required in the official announcement, as follows:

1. Motivation letter in English.
2. Detailed CV in English.
3. Certificate of master's qualifications in the field of biology, earth, marine or environmental sciences, biotechnology or relevant areas.

V– Evaluation of applications

Eight candidates were not admitted to the evaluation phase (**Table 1**) due to failure to meet one or more requirements stated in the official announcement. Two candidates were admitted to the evaluation and ranking phase (**Table 2**).

The Jury evaluated the application documents of the eligible candidates, and applied the classification criteria and the respective weightings set out in the notice of opening of the call, as shown in **Table 2**.

Criteria:

- 1) Experience in determining the nutritional profile of the biomass of salt-tolerant plants (25%).
- 2) Experience in the chemical characterization of extracts from salt-tolerant plants (25%).
- 3) Experience in determining the antioxidant properties of extracts from salt-tolerant plants (25%).
- 4) Experience in determining the enzyme inhibition properties of salt-tolerant plant extracts (25%).

The final grade and ranking of the eligible applicants are shown in **Table 3**.
